## Justice System Focused Proposed Workgroups

### 1. Failure to Appear

- Workgroup 1: Improve Court Appearance Rates
  - Goal: Reduce failure to appear rates by evaluating information made available to defendants about court dates, maximizing the use of this information, and exploring strategies to overcome barriers to court appearance.
  - Examples of Potential Policy or Practice Change:
    - Improved Court Notification Reminders
    - Increased access to receiving court reminders
    - Options for defendant initiated rescheduling of court dates
  - Potential Members: Self Help Center, DA's Office, Defense Counsel, District Court staff, CJS, Municipal Court staff, Court Services, Other **CICC Members**

## Justice System Focused Ideas, Cont.

- 1. Failure to Appear, continued
- Workgroups 2 (District Court) and 3 (Lawrence Municipal Court): Alternative Response to FTA
  - Goal: Reduce the use of jail as a response to Failure to Appear in appropriate cases by understanding the processes by which an Order for Arrest is issued for FTA, exploring alternative responses to FTA other than jail bookings, and evaluate reducing the length of stay for FTA-only bookings.
  - Starting Points for Workgroups:
    - Process map of current responses to failures to appear
    - Alternatives to jail booking that can be considered
    - Opportunities to reduce the length of stay for FTA-only jail bookings
  - Potential Members:

## Justice System Focused Ideas, Cont.

- 2. Alternative Responses to Probation Violations other than jail bookings
- Workgroup: Alternative Response to PVs for both District Court and Lawrence Municipal Court probation caseloads
  - Goal: Reduce the number of individuals booked into jail for violations of probation and reduce the length of stay in custody for these individuals
  - Starting Points for Workgroup:
    - Understand the types of violations of probation clients
    - Opportunities to reduce length of stay for PV jail bookings
    - Opportunities to reduce use of jail as a PV sanction, where appropriate
  - Potential Members:
    - DA's Office
    - Defense Counsel (for all clients)
    - Community Corrections
    - Court Services
    - Municipal Court Staff
    - CJS Adult Services (House Arrest)

## Justice System Focused Ideas, Cont.

#### 3. Jail Review Process

- Workgroup 1: Review larger populations of the jail bookings that may be drivers of jail population
  - Goal: Use data to evaluate specific populations of individuals that may be driving the jail population, which can also drive policy or practice change related to these populations
  - Starting Points for Workgroup:
    - Update Vera analyses through 2022 and the present as a starting point to evaluate how the impact of specific types of jail bookings have changed
    - Previously suggested workgroups can be a starting point for this type of jail review process
  - Potential Members:
    - CJCC

#### 4. Individual Jail Review Process

- Consider when to begin an iteration of this process
- 5. Racial and Ethnic Disparities
  - Proposal to embed Equity and Inclusion Consultant within each workgroup to provide equity lens
- Consider the existing workgroup and focus ongoing
